TERMS AND CONDITIONS Northern Territory School Excursion Program

Entry is open to any international study tour group linked to a primary, secondary or tertiary institution ('the Applicant'). The study tour must meet the following minimum requirements:

- Minimum 10 students in the group
- Itinerary must be for at least five (5) nights in the Northern Territory
- The trip must depart between 1 July 2018 and 30 June 2019
- Include at least three of the NT Learning Adventures experiences found on www.ntlearningadventures.com

Applicants may submit more than one application if there is more than one group (itinerary) planning to travel to the Northern Territory. The applicant shall retain discretion in allocating the funds between groups, in this case.

Applying for the program

Your application must include:

- A Registration Form completed in full and signed by a person authorised to bind the Applicant to the terms and conditions of this program;
- A detailed itinerary, showing main activities day by day;
- A statement of no less than 150 words explaining reasons why you are travelling to the Northern Territory
 including educational outcomes expected on the study tour; and
- A 'proof of purchase' of the study tour (this could be proof of deposits paid to agent, airline travel booked etc).

 Tourism NT reserves the right to substantiate these claims prior to payment of the program.

All applications must be received six (6) weeks prior to travel. Approved Applicants will be notified by phone or email.

Payment

If the application is approved by Tourism NT, an amount of AUD1,000 (inclusive of any and all applicable charges and taxes) will be paid as a lump sum to the Applicant.

In order to receive payment, the Applicant will need to:

- Complete and submit a Vendor Creation / Amendment Form;
- Submit an invoice to Tourism NT in their home currency and attach written evidence of the invoiced amount
 in their home currency being the equivalent of AUD1,000 for example, a printout from a currency conversion
 website such as www.xe.com/currencyconverter/

The payment will be made to the financial account of the Applicant.

After approval

The approved Applicant agrees to feature Tourism NT's 'Australia's outback' logo on their website or newsletter, student itinerary, social media or other marketing communications. Tourism NT will provide the logo in a suitable format along with any specific usage instructions and limitations. Any related marketing/promotional material produced by the education institution with reference to the Northern Territory study tour must be shared with Tourism NT.

The approved Applicant is required to provide Tourism NT with a report (in any format) on the study tour. This report must be delivered to Tourism NT no later than six (6) weeks after returning home from the Northern Territory or Australia. If the planned excursion is cancelled for. whatever reason, any monies paid as part of the funding must be returned to Tourism NT immediately.

The above terms are governed by the laws of the Northern Territory.
